
Minutes of the Meeting

Details of discussion points:

1. The fest is tentatively scheduled between 15th to 17th April. Further planning and coordination will be done to finalize the schedule.
2. The chair encouraged all students to actively participate in the upcoming sports meet to promote physical fitness and team spirit.
3. It was noted that the representation from 4th-year students is minimal.
4. Moving forward, from the next academic year, Student Council nominations will primarily include 2nd and 3rd-year students to ensure continuity in leadership.
5. Students are required to carry their ID cards at all times while on campus to ensure proper identification and adherence to institutional regulations.
6. Due to the high number of students arriving late, strict measures will be implemented to address this issue.
7. Students are required to remain in their scheduled classes during instructional hours and should not be in the library or canteen unless they have obtained prior permission.
8. **The chair has instructed that, for safety, students must adjust the direction of wickets during cricket games and utilize the designated practice nets.**
9. Members were instructed to **inform students to avoid loitering** around the campus during academic hours.
10. The chair suggested that a **core and sub-core committee list** be prepared for the fest to ensure smooth coordination.
11. The GCET Podcast is currently operational; however, to facilitate the production of new episodes, students have requested a camera. The chair advised submitting a formal request through the faculty coordinator or contacting the Department of Photography (DOPY) Club for assistance.
12. The Chair has instructed that students with **good attendance records** will be given priority to attend the fest and other college events.
13. The next meeting is tentatively planned for March 2025.

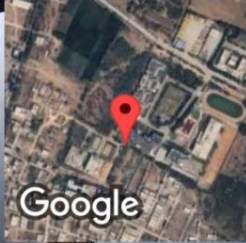
